Members also have the right to withdraw their consent at any time by contacting the Membership Secretary at the above address. Bude Canal & Harbour Society holds data supplied by its members on their application to join the society. It may include an e-mail address as well as name, postal address and telephone number. This information is stored on the society's computer which is protected by a password known only to the Membership Secretary and a named deputy (for emergency use only). It is used to administer the business of the society such as sending AGM or EGM notices and other relevant documents to its members. This information is not shared with any other organisation or member and it is kept until the member leaves, resigns, lapses or is confirmed as deceased. It is then deleted from the society's records. The data stored is only that which is collected from the member. Members are therefore encouraged to inform the society of any changes to their contact details such as postal address, telephone number or e-mail address so that we can remain in contact.
